The Government announced some weeks ago its new scheme, **Kickstart**, helping young people into work. Information has been slow in coming out, particularly if you are not in a position to offer 30 placements. The Business Growth Hub has now established itself as an intermediary matching young people with local employers. Funding is available to you as the employer, as long as you provide a 25 hr per week job placement, to cover the wages and training and development. ### A reminder **that Brexit is not that far away!**

The UK has left the EU and will leave the EU Single Market and Customs Union at the end of the year. With less than 100 days until the end of the transition period, businesses should take action now to start preparing for new trading rules which will come into effect from January 2021.

To help you prepare, here are four things you should do:

1. Head to [GOV.UK/transition](https://www.gov.uk/transition) to take a short survey and receive a personalised list of actions for you and your business to take.
2. If you're an exporter, find out what you need to do to [continue to export goods to the EU](#).
3. If you're an importer, find out what you need to do to [continue importing goods from the EU](#).
4. [Sign up to email alerts](#) to stay up to date with any further changes.

These are concrete steps you can take now to minimise disruption and take advantage of new opportunities.
